Olympia Duhart is a Professor of Law at the Shepard Broad Law Center where she has served as the Director of the First-Year Lawyering Skills and Values (LSV) Program since 2012. The LSV Program combines legal research and writing with practice-oriented skills training. Duhart is co-president of the Society of American Law Teachers and serves on several professional advisory boards. Before joining the faculty at Shepard Broad in 2005, she was one of the founding members of the Critical Skills Program at the Law Center and practiced law at Ruden McClosky. Prior to law school, she taught high school English and was a staff writer for The Miami Herald. She has also been published in The Huffington Post and The New York Times. She has authored legal publications and presented at law conferences across the United States. Professor Duhart earned her J.D. *magna cum laude*, from Nova Southeastern University's Shepard Broad Law Center in 2003.



Camille Lamar is as an Associate Professor of Law at the Shepard Broad Law Center, teaching courses in legal research and writing, interviewing and counseling and in the Masters of Law online program. She was a law clerk for US Magistrate Judge Charles S. Coody, and later, a staff attorney for US District Judge Karon O. Bowdre, managing a heavy docket and drafting orders on a variety of civil matters. She practiced municipal law for the City of Anniston, AL., and later as a litigation associate in Birmingham, AL, handling issues related to education law.

Professor Lamar was a teaching fellow at Cumberland School of Law and an adjunct professor at Miles Law School, both in Alabama, before she joined the faculty at the Law Center in 2007. She has authored law review articles on the topics of legal research and writing and has lectured on topics in higher education, curriculum reform, and time management. Professor Lamar earned her J.D. from Cumberland School of Law in 1996.



Beverly A. Pohl is a Partner in the Fort Lauderdale office of Broad and Cassel, and Chair of the firm's statewide Appellate Practice Group. Ms. Pohl has been Board Certified in Appellate Practice by The Florida Bar since 2002, and handles a wide variety of civil and criminal appellate matters in state and federal appellate courts.

A Fellow of the American Academy of Appellate Lawyers, Ms. Pohl has been listed in The Best Lawyers in America in the area of Appellate Law for ten years.
