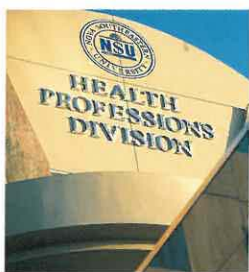

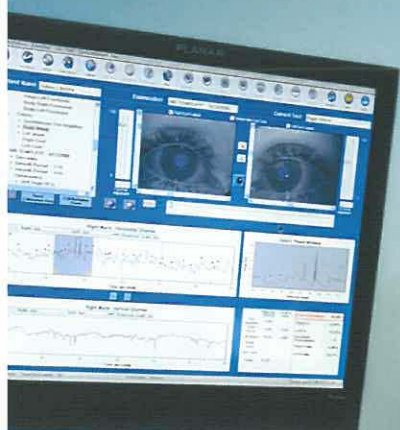

## PROGRAM OVERVIEW

The Doctor of Audiology (Au.D.) establishes audiologists in a clearly defined and prominent role within the hearing health care delivery system and strengthens their position as autonomous practitioners. The degree provides the academic foundation and diverse clinical experiences necessary to enter professional practice today and to stay abreast in the future. Doctor of Audiology students enroll in a clinically focused professional doctoral program where students complete a rigorous academic curriculum to augment and expand upon their current knowledge and skills in the field of audiology.



## PROGRAM OUTCOMES

The graduate earning an Au.D. from the audiology program will be able to

- 1.** demonstrate assessment methodology and the interpretation of assessment results with a variety of clinical populations
- 2.** develop and implement a plan for audiological management and treatment based on clinical diagnostic data with a variety of clinical populations
- 3.** collaborate and/or counsel effectively with clients, family members, care givers, and other professionals
- 4.** evaluate and critically apply current research to determine and enhance clinical efficacy
- 5.** demonstrate ability to assume a leadership role in business practices and supervision
- 6.** apply appropriate technologies to accomplish research, diagnosis, management, and treatment

## UNITED KINGDOM PROGRAM

The audiology department offers the Doctor of Audiology (Au.D.) program for audiological scientists and other qualified audiology practitioners. Faculty members from the United Kingdom and United States are partnering to offer the most diverse and advanced professional degree program in the world. Courses are offered in London, every other month, in an extended weekend format. By earning the Au.D., the graduate will enter one of the fastest-growing professions in the world. Our program at NSU is designed to prepare current audiology practitioners to respond to the expanding scope of professional practice and the continual technological advancements of the profession. # ADMISSIONS REQUIREMENTS

1. master's degree (M.Sc.) or equivalent in audiology
2. evidence of one year of clinical work experience as an audiologist

## NONMATRICULATING STUDENTS

Those students who wish to take a module without formally entering the program may do so by completing a nonmatriculating application. Up to 9 credit hours may be taken in this category.

Students are provisionally admitted to a degree-seeking program based on a review of unofficial transcripts or other specific program admission requirements. However, this admission includes a condition that final and official transcripts, documents, and requirements must be received within 90 calendar days from matriculation. If these final and official transcripts, documents, and/or requirements are not received by that time, the student will not be allowed to continue class attendance. Students who have an unpaid balance 30 days from the start of the term will be assessed a \$100 fee.



# APPLICATION PROCEDURES

Applicants must submit

1. a completed application form along with a \$50, nonrefundable application fee
2. three letters of recommendation from professors and/or supervisors
3. all coursework from institution(s) applicant attended or is a graduate of

Applicant is responsible for contacting one of the evaluation services listed here if coursework was taken outside the UK or the United States. The official evaluation must be sent directly from the evaluation service to the EPS.
