### College Accomplishments

#### Curriculum Committee Critical to Accreditation Success

The support of the curriculum committee played a prominent role in securing full reaffirmation from the Accreditation Council for Pharmacy Education (ACPE). In 2018, the curriculum committee, under the leadership of Graciela Armayor, Pharm.D., director, curriculum development and assistant professor, began the daunting task of implementing a new curriculum developed to meet, at the time, the updated accreditation standards. The revised standards aimed to make students more practice and team ready upon graduation. There were many layers involved in implementing this new curriculum and members of the committee worked hard to ensure their efforts supported the task, which ultimately provided the foundation for a successful self-study.

During these years, the committee revamped the course review and team processes, and embedded certifications within the curriculum, such as immunization, smoking cessation, and MTM. The new curriculum was built in a block structure with threads of disease state information strategically integrated into the course sequences. "Life" continued to happen through the process and faculty members had to work through logistical challenges across three campuses, who at times were impacted by natural disasters such as hurricanes and earthquakes, as well as the pandemic. Thank you to all the members of the curriculum committee for their hard work and commitment to success.

## Interprofessional Simulation Complex Groundbreaking

On November 22, 2022, NSU unveiled the Interprofessional Simulation Complex, a part of NSU Health, on the site of the Miami Dolphins former football training facility. The special groundbreaking ceremony was attended by more than 100 NSU stakeholders, key officials, students, and supporters.

At NSU Health's Interprofessional Simulation Complex, the combination of teamwork and technology will augment the educational experience, enrich clinical training, and accelerate medical innovations. The \$56 million, 107,000-square-foot interprofessional complex will be used by NSU students, community groups, health care corporations, and practicing physicians for advanced training exercises, research, equipment demonstrations, and surgical scenarios. More than 105 simulation spaces will be offered including 3-D modeling/animation, virtual, augmented, and mixed reality, holograms, 16 human and fresh tissue stations, operating rooms, team-scenario venues, inpatient skills labs, and outpatient exam rooms. #### Faculty Secure Funding for Research

Benedict C. Albensi, Ph.D., BCMAS, CRQM, professor and chair, Department of Pharmaceutical Sciences, is a Co-Applicant on a funded \$740,000 grant from the Canadian Institutes of Health Research (CIHR). He and his team members from the University of Manitoba and the University of Alberta submitted a project entitled *"Perinatal nutrition strategy with omega-3 docosahexaenoic acid (DHA) to protect brain in fetal alcohol spectrum disorders"*. The grant was ranked number one out of 31 submissions. A contributing factor to the ranking was the excellent team of faculty with diverse and complementary expertise, who are all productive researchers. The plan addresses an important public health problem – Fetal Alcohol Spectrum Disorder that is particularly relevant among Indigenous people. The 5-year program will use a

model to examine the effects of prenatal alcohol exposure and whether these negative effects are modified by maternal omega-3 DHA intake. Omega-3 fatty acids are "healthy fats" found in fish and plants and are being shown to have many health benefits.

Narasimman Gurusamy, M.Pharm, Ph.D., assistant professor, Department of Pharmaceutical Sciences, whose research concerns heart disease, recently won a grant from the American Heart Association called *'Autologous induced-mesenchymal stem cells and their exosomes therapy for myocardial injury'*. This award will examine the use of stem cells for the treatment of heart muscle disease, which have been shown to both treat the symptoms and improve heart function. This study will generate stem cells from human urine-derived cells through cellular reprogramming. A successful completion of this project will help to treat heart muscle disease with the patient's own cells, generated without any surgery.

#### Faculty Address the Pharmacist's Role in Improving Contraceptive Knowledge and Access

Assistant professors from the Department of Pharmacy Practice Andrea Levin, Pharm.D. ('09) and Karen Berger, Pharm.D. recently published an article in the Journal of the American Pharmacists Association (JAPhA) addressing the pharmacist's role in improving contraceptive knowledge and access. As the nation digests the Supreme Court's decision to overturn Roe vs. Wade, health care providers have paused to evaluate their role in an uncertain future. Many states have legislation in place that allows pharmacists to prescribe or dispense select hormonal contraceptives without a prescription. It is known that pharmacists have the knowledge and training to participate in contraceptive education and management, but some may struggle with feeling empowered to do so.

Advocating for legislation to expand the pharmacist's role in this setting can improve patient access to hormonal contraceptives. Now, more than ever, pharmacists' involvement in hormonal contraceptive management will be a necessary step to improving patient care. We thank Drs. Levin and Berger for tackling this important and timely topic and emphasizing the important role pharmacists play in educating

Genevieve M. Hale, Pharm.D. ('13) , associate professor, Department of Pharmacy Practice, along with two highly motivated pharmacy students, Bailey Bruns ('23) and Shirley Lorenzo-Castro ('23), recently published "Controlling Blood Pressure During a Pandemic: The Impact of Telepharmacy for

*Primary Care Patients*" in the Journal of Pharmacy Practice. This study highlights the importance of telepharmacy services for patients with hypertension that were unable to physically see their primary care provider during the COVID-19 pandemic. Their findings suggests that the utilization of either in-person or telepharmacy strategies benefit the management of hypertension.
