CFP and Certified Financial Planner are service marks of the Certified Financial Planner Board of Standards. Nova Southeastern University's program meets the standards promulgated by the Certified Financial Planner Board of Standards.

Students who enroll in the Certified Financial Planner Certificate Program will take five financial planning courses to earn the certificate.

These courses may be applied as electives toward the master of accounting degree at NSU.

ADMISSION REQUIREMENTS

The applicant must:

1. Hold a bachelor's degree from a regionally accredited institution.
2. Submit a completed application form accompanied by a \$40 application fee.

CERTIFICATE REQUIREMENTS

To satisfy the requirements of the Certified Financial Planner Certificate Program, a student must complete the 15 credit hours of study successfully. A student must maintain a minimum grade point average of 3.0 in order to receive the certificate.

LENGTH OF PROGRAM

The certificate program can be completed in nine months. Each term is three months in duration. Students can complete the program by enrolling in two courses/six credits their first two terms and one course/three credits their final term.

PROGRAM FORMAT

The program format consists of four terms per year, with classes meeting five alternate weekends per 13-week term.

Early Session:

Friday	8:15 P.M. - 10:15 P.M.
Saturday	1:00 P.M. - 5:00 P.M.

STARTING TIMES

Classes start in January, April, July, and October. Students can begin in any of the four terms.

PROGRAM LOCATIONS

Classes are held in Fort Lauderdale (east campus) and South Miami. Other locations are currently being developed. Off-campus cluster sites are served by a local cluster coordinator.
