## What's New At Nova? Lots Of Things ...

### Law School

The new Law School Board of Governors, chaired by **Ray Ferrero**, Esq. of the firm Ferrero, Middlebrooks and Strickland of Fort Lauderdale, comprises prominent civic and professional leaders of the Dade/Broward, Palm Beach community, actively committed to helping "promote, expand and enhance the further development of Nova University and its School of Law."

One of the Board's tasks will be to advise on how best to use the interest on the \$5 million endowment allocated to the Law School by Nova University out of the recently settled \$16 million Leo Goodwin Sr. Unitrust.

The University's Board of Trustees has designated the interest on \$1 million to be used for professorships, scholarships and student loans. A portion of this fund has been earmarked for "Distinguished Professors," the first of whom is **Mr. Justice Arthur J. Goldberg**, who will arrive at the university in August of this year.

Interest on the next \$2 million is being set aside toward the purchase of the new Law School building (at 3100 SW 9th Ave., Ft. Lauderdale), now being leased from Olympia and York, in ten years. The remainder will be used for law-related inter-disciplinary programs, the purchase of special law library materials, and anything else the Law School might need to "maintain optimum standards."

The new Law School facility, spacious as it is compared to its former temporary quarters in the Parker Building on Nova's main campus, is still not large enough to house a law library with the 250,000 or more volumes the

### Corporate Programs

In response to request from industry in Broward County, Nova College has developed a new corporate unit which will be directed by **Dr. Anna Mae Burke**. Bachelor degree programs in Electrical Engineering, Electronic Technology, Computer Science, and Mathematics, and Certificate programs in Basic Electronics, Advanced Electronics and Computer Science have been developed. Classes in these programs will begin in March.

The programs are structured in such a way that the student does not have to decide his or her major within these areas at the beginning of the program. The concept of a second Bachelor degree for those who now feel the need of technical credentials is also being stressed. Classes will meet both on the main campus and at industrial sites in nine-week cycles. The second cycle will begin May 5th.

Opportunities will be provided for students to test out of specific courses using written, oral and-or laboratory demonstrations so that they may validate on-the-job learning experiences.

### Administration

On Feb. 1, a new **Center for the Study of Administration** was formed, incorporating the Public Affairs programs, Criminal Justice, Graduate Management, the Governmental Assistance Service, and certain Computer Science Management programs. The Center will maintain close ties with the National Ed.D. Program for Ed. Leaders, the Law Center and the Office of New Programs.

**Dr. John M. Clarke**, Director of the Center, asserts that he is committed to the exploration and use of improved delivery systems, the application of diagnostic methods to teaching Business and Public Management, and the improvement of course content and faculty. The Center will retain the national character of the DPA programs and pursue new developmental approaches and closer ties with the business community and needs of South Florida.

**Dr. David Britt** is the Associate Director of CSA with primary responsibility for the DPA and the Criminal Justice programs. **Jane Whitney** is the Assistant Program Director for the DPA program, although she will be teaching in both Public Affairs and Business. **Dr. Martin Veiner** will head the DBA program. And **Margaret Shearon**,

## Summer Dreams — And Triumphs

Summer climbed three steps to the top of the toddler slide, looked around to make sure everyone was looking, sat down stiff legged and slid down to the bottom. "Good girl!" Summer's mother cheered, giving her daughter a hug. Brad, who had just learned to clap his hands, joined the circle of mothers in applauding Summer's feat.

"Summer's motor skills are progressing beautifully," I commented. "How is her language coming?" "Nothing new this week," Summer's mother replied. "I guess you can't expect miracles."

While we were talking, Summer picked up a rubber doll and toddled back to the slide. Clear as a bell, her voice sounded, "Dolly, up!" Her mother's eyes flooded with tears. For the first time in her life, Summer had said two words.

The Ring-A-Round program at Nova University is a play group for developmentally delayed infants and toddlers. Although "miracles" do sometimes happen, Ring-A-Round is designed, not as a therapeutic program but simply as a play group experience for children and parents who need opportunities for socialization.

The morning begins around 10:00 a.m. Mothers, and occasionally fathers, sit in a large circle holding their babies in front of them. Following the "Hello Song", in which each child is greeted by name, there is a series of simple group activities: exercises, nerf ball rolls, swaying to music, and a rattle rhythm band. After a few group activities there is a "Share and Show" where each mother can show the group the games or activities that her child enjoyed during the week.

Following "Share and Show", there is a free play session in which parents have an opportunity to talk with each other while their babies play in a "Make a Mess" session.

The Ring-A-Round program is perhaps more unique in terms of what it is not, than what it is. In contrast to most programs for children with developmental problems, Ring-A-Round is neither therapeutic, in the literal sense, nor individualized. Rather than emphasizing and highlighting individual differences, Ring-A-Round emphasizes needs and characteristics that handicapped and non-handicapped children have in common. It recognizes not only the needs of infants to have fun in a group, but also the needs of parents to interact with other parents in an "upbeat" environment.

### Conference On Aging

"Enhancing the Quality of Life in the Later Years" was the theme of the Second Annual Behavioral Conference on Aging sponsored by Nova's Behavioral Sciences Center January 23-26, at the Galt Ocean Mile Hotel, Fort Lauderdale.

Nationally recognized authorities in Gerontology, Psychology, the Social Sciences, Medicine, Education, Architecture, and Political Planning shared current research findings and opinions, and discussed their implications for community program development, service delivery and training of mental health practitioners.

The conference was by subscription, but Friday afternoon's program was free and open to the public. There were display booths by community organizations and agencies dealing with problems of the aged, and a presentation by **Betty Ann Badger**, Professor of Gerontology at Nova, Director of the South Florida Geriatric Center and Consulting Professor of Gerontology for WINZ radio.

## STUDENT OF THE MONTH

Anil Edwards has come a long way in pursuit of his goals. This May, when he graduates from Nova with a masters degree in Learning Technology, he'll have taken a giant step in the direction of what promises to be an exciting new career.

Born in India of parents who were both school teachers, he quite naturally gravitated toward teaching — after earning two bachelors degrees, one in Liberal Arts, and one in English as a Second Language. He taught for two years in Calcutta, and then, because of a health problem, came to America where he found a job with a chemical company as a laboratory technician. ("Not that I was that great in science, although I had taken several science courses at St. Stephens college in New Delhi," Edwards laughs. "I was a simple matter of survival. I needed a job and they offered me one.")

Since then, he's worked for several companies on a variety of technical projects. And then, one day a few years back, he realized that the dissemination of information — making training tapes, producing manuals, and such — was as much a vital part of any research and development project as the engineering which created the product in the first place. That was when he enrolled in Nova's Learning Technology program — and found a whole new conceptual world opening up to him.

Edwards is now writing a manual for the operation of a multi-image control system. This manual, however, uses pictorial symbols which can be readily understood by almost anyone — not just a graduate engineer.

"The things I learned in semantics class, particularly those classes taught by the late Dr. Richard Bell, for me thinking about ways to communicate highly technical concepts," he explains. "I started experimenting with symbols, and discovered that through symbols, I could communicate complex ideas more clearly. What I've learned at Nova is really the basis for the whole concept."

"Now, if you ask me what I want I want to do with my life — in the best of all possible worlds, of course — I'd have to say I'd like to make educational films for children," Edwards says. "I'd like to make nature films to make them more aware of the beauty they're born into, and better able to cope with the world and its natural environment. I'd like to make films to teach children about simple machines to help them understand how they can use machines to help them do many things. I think this would give me the greatest satisfaction, professionally and personally."

### Testing, Testing...

No one likes taking tests — until they see how useful they can be in helping a young person plan his future college and career goals.

This year, for the first time, sophomores as well as juniors, at the University School were allowed to take the PSAT exams to give them some idea of how they stand in relation to other students around the country, and to let them begin making realistic plans for college. Reportedly, they did quite well, with scores ranging up to 1370.

The sophomores were also given the opportunity to participate in a three-hour test designed to give special information on their career potential. The tests were in three parts: an abilities measure, an interest inventory, and an information measure.

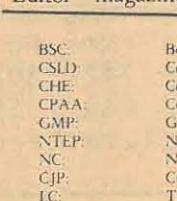

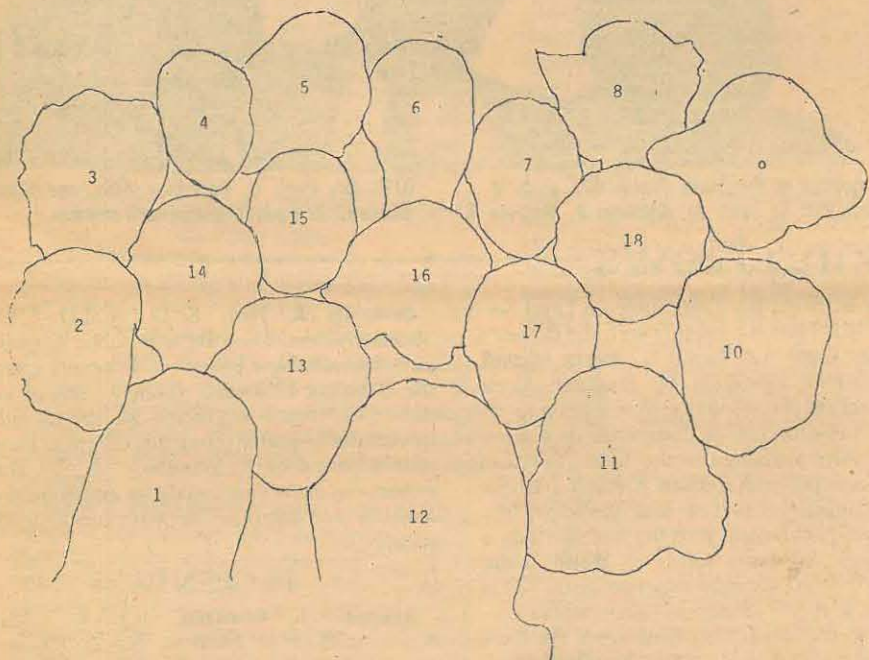
Planning The Derby Ball

supported by Dr. Phyllis Brick, will be responsible for all masters degree programs offered by the Center. Dr. George Graham will continue as academic advisor to the Center Director and National Preceptor Coordinator for the DPA. All of these (with the exception of Dr. Graham) will do some teaching in addition to their administrative duties, and assist in the support of all university programs where the specialties can be constructively applied.

Dr. Charke estimates that it will take between 60 and 90 days for the new Center to become fully integrated. Steps have already been taken toward that end as evidenced by the appointment of Nancy

Varner as Assistant Director for Market Development, the expanded use of the GMS student information system for all Center programs, the standardization of faculty rank criteria (pending before the Personnel Committee), and Dr. Clarke's announced intent to streamline registration and support activities.

"a primary goal of the Center," Dr. Clarke says, "is to produce a quality educational product with offerings in all fields of Administration. We are dedicated to providing the professional skills of business and public managers nationally. Innovation will be a critical part of this task, and close ties with the Offices of New Programs will be important to the Center's purpose."
