

ORGANIZATION OF BOOKS:

The Law Library uses the Library of Congress classification system. The call number on the spine of the book corresponds with the record in our computer catalog, NOVACAT. Unclassified materials may be found by the location code in NOVACAT.

LAW REVIEWS, PERIODICALS, JOURNALS:

Current issues are arranged alphabetically by title and shelved behind the Circulation Desk. Bound volumes are shelved alphabetically by title on the third floor. Specific titles and holdings can be found in the NOVACAT computers.

COMPUTER SEARCHES:

NOVACAT, GovDocs, WilsonDisc, UN Index and Internet research are located on the stand-alone terminals on each floor. Other legal databases, such as Westlaw and Lexis/Nexis, are available only to NSU Law students, law faculty, and law staff by personal password.

SPECIAL COLLECTIONS:

The Law Library has special collections in Federal, State, and U.S. Territories' Administrative and Case Law; Admiralty Law; Tax Law; Florida Law; Law and Popular Culture; Florida Bar Continuing Legal Education; Government Documents; and United Nations Documents. We have a large collection of law reviews, journals and periodicals, microforms and legal reference material.

BOOK LOANS:

Because of the research nature of the Law Library, most items do not circulate. Those items which do circulate may be checked out for two weeks to any NSU student, faculty, or staff member with a current NSU picture I.D. Privileges are also extended to NSU Law Alumni Association dues-paying members.

RENEWALS:

Books may be renewed if not requested by another patron. Phone renewals are available.

OVERDUE FINES:

Overdue fines are \$.50 per day, per item on regular circulating materials, and \$.50 per hour, per item on Reserve materials.

OTHER LIBRARY SERVICES:

Photocopiers are located on each floor next to the elevators.

Restrooms are located on the east side of each floor.

Telephones are located near the center of the second and third floors, and on the east side of the first floor.
