Nova University Law Center, established in 1974 and granted provisional accreditation by the American Bar Association in 1975, will graduate its charter class on May 22, 1977.

With approximately 500 students, a fulltime professorial staff of 20 and a library of about 100,000 volumes, Nova University has a unique opportunity for developing in Broward County one of the nation's finest centers for the study and research of law.

The study and practice of law, perhaps more than any other discipline, has the most immediate, dramatic and measurable potential for improving the quality of life in the country and in the Broward County community.

As with each of the components comprised by Nova University, the Law Center is expected to and does generate tuition revenue necessary for meeting its operating expenses. Although tuition revenue is sufficient for this purpose, it cannot also provide the funds necessary for developing excellence in all phases of the program.

The Law Center has a particular need for endowed scholarship funds which can be used to provide tuition assistance to students with a demonstrated need and academic potential. Such an endowment fund will help to enrich the student population by providing access for students who have demonstrated ability but who, for economic reasons, are being denied the opportunity for developing their knowledge and skills.

In order to help provide scholarship support, the members of the Board of Governors of the Law Center ask your participation in the ENDOWED SCHOLARSHIP FUND CAMPAIGN.

All funds committed to endowed scholarships will be invested, with interest only being used for student support and the principal remaining in perpetuity.

All funds committed for "Living" endowed scholarships will be used each year for student support.

Funds may be committed on a combined basis, with a portion being invested to build an endowed scholarship and the remainder being committed for current student support.

Scholarships, whether endowed or "Living" will be identified in perpetuity with the name of the donor or donors.
