


Groups and individuals may be screened for hearing, speech, or language problems. University faculty and graduate students will go to the site to provide screenings.

Diagnosis and Treatment of Speech and Language Problems

DIAGNOSTIC EVALUATIONS

- Voice, laryngeal problems, laryngoscopy, and laryngectomy
- Articulation and phonology
- Language (undeveloped or loss of language due to illness or injury)
- Fluency and stuttering
- Dysphagia (swallowing problem)
- Disorders associated with:

Stroke (aphasia) Parkinson's disease Cerebral palsy Cleft palate Head Injury Autism Attention deficits

- Accent reduction
- Augmentative and alternative communication

Evaluations are conducted by or under the supervision of specialized faculty. Approximately two to three hours are required for a diagnostic session. A report is rendered with recommendations for treatment. Clients in need of therapy are assigned to a specialist and graduate student for sessions as recommended. Private sessions with specialists are available. Support groups for clients and spouses are scheduled as a part of treatment.
