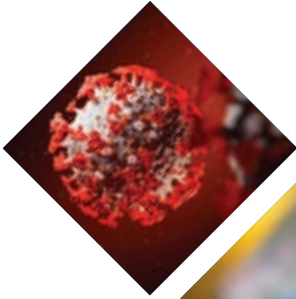

PUBLIC HEALTH

MASTER OF PUBLIC HEALTH PROGRAM INFORMATION

NSU's Master of Public Health (M.P.H.) Program offers a generalist M.P.H. degree, which requires a minimum of 42 credit hours of study. This consists of

- 27 credit hours of required core courses
- 15 credit hours of public health elective courses
- coursework, taken on a full-time or part-time basis, as long as the course of study is completed within five years of matriculation

A full-time student may be able to complete the requirements in as little as one year.

NSU's M.P.H. degree may be completed on-site or online. Online courses are synchronous.

- On-site and online classes are offered in the evening and are generally scheduled one evening per week.
- Orientation is required for both online and on-site students prior to matriculation into the program.

Students must maintain a grade point average (GPA) of 3.0 on a 4.0 scale to remain in good academic standing.

MASTER OF PUBLIC HEALTH EXIT OPPORTUNITIES

The M.P.H. program at NSU's Dr. Kiran C. Patel College of Osteopathic Medicine provides a comprehensive, graduate-level program designed to prepare students to define, critically assess, and resolve public health problems. It emphasizes acquisition of knowledge and skills for promoting health, preventing disease, developing and evaluating programs, enhancing clinical practice, conducting research, and providing community service.

NSU's M.P.H. degree is a recognized degree for leadership in health care. The curriculum enhances understanding of the biological, social, environmental, demographic, and political factors that determine the health of the individual and the population.

The program—offered on-site and online—is generalist in nature. Students have the opportunity, through a number of elective courses, to enhance their knowledge and skills in a variety of public health disciplines.

This degree also complements other health profession degrees and provides candidates with the highly sought-after skills necessary to respond to changes in the health care environment.

Did You Know?

The number of health care management jobs in the United States is anticipated to increase sharply in the coming years. According to the U.S. Department of Labor, Bureau of Labor Statistics, employment of medical and health services managers is projected to grow 17 percent from 2014 to 2024, much faster than the average for all occupations.

MASTER OF PUBLIC HEALTH ADMISSIONS REQUIREMENTS

All application materials must be received in a timely manner to enable the Office of Admissions and the admissions committee to process the application promptly.

All applicants for admissions must have a minimum of a bachelor's degree from a regionally accredited college or university.



MASTER OF PUBLIC HEALTH APPLICATION PROCEDURES

NSU's M.P.H. program evaluates the overall quality of applicants, including academic achievement, personal motivation, knowledge about the public health profession, health care and life experiences, and recommendations. Applicants may apply for matriculation into any one of three semesters (fall, winter, or summer) and may access the M.P.H. program website (osteopathic.nova.edu/ph/mp/h) for exact deadlines and start dates.

Applicants must provide the following:

1. **a completed online application**, along with a nonrefundable application fee of \$50, to osteopathic.nova.edu/apply-now
2. **official transcripts of all coursework** attempted by the applicant at all colleges and universities

It is the responsibility of the applicant to ensure that arrangements are made for all transcripts to be sent. A final transcript of all the applicant's work up to the time of matriculation must be forwarded to the Office of Admissions prior to matriculation.

Coursework taken at foreign institutions must be evaluated for U.S. institution equivalence by an approved National Association of Credential Evaluation Services (NACES) organization, such as one of the services listed below.

It is the applicant's responsibility to have this coursework evaluated. An official course-by-course evaluation with a cumulative grade point average must be sent directly from the evaluation service to NSU's Enrollment Processing Services.

3. official standardized test scores

- taken within five years of matriculation
- MCAT, GRE, PCAT, OAT, DAT, GMAT, or LSAT accepted
- required unless applicant has an overall minimum GPA of 3.0 on a 4.0 scale

4. demonstration of English proficiency by any applicant whose native language is not English or who has graduated from a college or university where English is not the primary language, regardless of U.S. residency status (The standardized tests below currently satisfy NSU's and this program's English requirements for non-native English speakers. Test results must be sent directly from the testing agency to the center where you applied.)

- Test of English as a Foreign Language (TOEFL): minimum score 213 on the computerized or 79–80 on the Internet-based
- International English Language Test System (IELTS): score of 6.0 on the test module
- GMAT: score of 450
- GRE: score of 306
- Scholastic Assessment Test (SAT): score of at least 500 in the reading section
- American College Test (ACT): score of at least 20 on the verbal section

Proof of English language competency can also be in the form of successful completion of a bachelor's degree or higher at an approved U.S. institution of higher education.

5. two letters of recommendation

- one from a health professional
- one from an individual (other than a relative), such as an academic adviser, professor, coworker, or supervisor, who is familiar with the applicant's character, scholastic aptitude, and work ethic

Upon receipt of the completed application and required materials, the Committee on Admissions will review the application and make recommendations to the program director. The final decision on admission is made by the dean.

Applicants enrolled in another area of study within Nova Southeastern University must

- be in good academic standing
- provide a letter of recommendation from the dean or program director of the other college or program
- meet the M.P.H. admissions requirements

MASTER OF PUBLIC HEALTH TRANSFER OF CREDITS

Applicants or matriculated students of NSU-KPCOM's M.P.H. program may petition for transfer of a maximum of 12 credit hours of elective or core courses toward their M.P.H. degree from a regionally accredited graduate program. Please note that

- Any core courses to be transferred must have been taken at a program, school, or college accredited by the Council on Education for Public Health (CEPH).
- Students enrolled in NSU's M.P.H. program who want to transfer credit from another academic program or institution must have prior approval from the NSU-KPCOM M.P.H. program director.
- All courses considered for transfer into the program must have been successfully completed with a grade of B or better and must not have been applied to another awarded degree.
- Transfer course grades are not calculated toward the student's grade point average.
- The applicant must submit a written request to NSU-KPCOM's program director, along with the appropriate verification of documents (e.g., official transcripts, syllabi, and catalogs).
- The program does not give course credits for prior work experience.

The Curriculum Committee will review the documents provided for all applications for transfer of credits and will submit recommendations to the program director. The final decision on admission is made by the dean.



MASTER OF PUBLIC HEALTH NONDEGREE-SEEKING STUDENTS

A nondegree-seeking student is one who wishes to take courses in the graduate-level public health program up to a limit of 12 semester hours, but does not intend to pursue the M.P.H. degree. The nondegree-seeking student must provide the following in order to take classes in NSU's M.P.H. program:

- a completed application form
- official transcripts
- a nonrefundable application fee of \$50

If, after taking classes in NSU's Master of Public Health Program, a nondegree-seeking student decides to pursue the M.P.H. degree, the student must submit a new and complete application to the program to become a degree-seeking student and must meet all the requirements for admission to the M.P.H. program.

Previous coursework taken as a nondegree-seeking student does not guarantee acceptance into NSU's M.P.H. degree-seeking program.

The university reserves the right to modify any requirements on an individual basis as deemed necessary by the dean of NSU's Dr. Kiran C. Patel College of Osteopathic Medicine. The college reserves the right to require a student's withdrawal any time the college deems it necessary to safeguard its standards of scholarship, conduct, and compliance with the regulations, or for such other reasons as deemed appropriate. Students, by their act of matriculation, concede the college this right.



PUBLIC HEALTH

NSU's Graduate Certificate in Public Health is

- designed to enable students to acquire core knowledge that applies to the fundamental principles and practice of public health
- a competency-based program consisting of 15 credit hours of core graduate-level public health courses presented using online technology

Each course must be successfully completed with a grade of C or better to be eligible for the certificate.

The certificate will be presented to students after all curriculum requirements are successfully met.

Did You Know?

Previous coursework taken as a nondegree-seeking student does not guarantee acceptance into NSU's M.P.H. degree-seeking program, but may be transferable if performance equals or exceeds the grade of B in each course, and meets the admissions requirements.

HEALTH EDUCATION

NSU's Graduate Certificate in Health Education is

- designed to enable the student to learn the fundamental principles, concepts, and skills applied to health education, health promotion, and disease prevention at the graduate level
- a competency-based graduate certificate program consisting of 15 credit hours of graduate-level public health courses presented using online technology

The competencies defined in this program are selected from competencies of the National Commission for Health Education Credentials and are defined in the course syllabi.

Each course must be successfully completed with a grade of C or better to be eligible for the certificate.

The certificate will be presented to the student after all program requirements are successfully met.

If, after taking three courses in the certificate program, a certificate-seeking student decides to pursue the M.P.H. program, the student must submit a new and complete application to become an M.P.H. student and must meet all requirements for admission to the M.P.H. program. Previous coursework taken as a certificate-seeking student does not guarantee acceptance into the M.P.H. program. If accepted into the program, credit hours with the prefix PUH, taken as a certificate-seeking student, will be applied toward the M.P.H. program.

ADMISSIONS REQUIREMENTS/APPLICATION PROCEDURES

Applicants must submit

1. **a completed online application** and a nonrefundable application fee of \$50 to osteopathic.nova.edu/apply-now
2. **official transcripts** of all undergraduate, graduate, and professional education (The applicant must have a minimum of a bachelor's degree from a regionally accredited college or university.) Please note that preference will be given to applicants with an undergraduate cumulative GPA of 3.0 or above on a 4.0 scale.

Coursework taken at foreign institutions must be evaluated for U.S. institution equivalence by an approved National Association of Credential Evaluation Services (NACES) organization. Agencies that can complete this evaluation can be found at nova.edu/internationalstudents/prospective/credentialservices.html.

It is the applicant's responsibility to have this coursework evaluated. An official course-by-course evaluation with a cumulative grade point average must be sent directly from the evaluation service to NSU's Enrollment Processing Services (EPS).

3. **demonstration of English proficiency** by any applicant whose native language is not English or who has graduated from a college or university where English is not the primary language, regardless of U.S. residency status (The standardized tests listed here currently satisfy NSU's and this program's English requirement for non-native speakers. Test results must be sent directly from the testing agency to the center where you applied.)
 - Test of English as a Foreign Language (TOEFL): score of 213 on the computer-based test or 79-80 on the Internet-based test
 - International English Language Testing System (IELTS): score of 6.0 on the test module

- GMAT: score of 450
- GRE: score of 306
- Scholastic Assessment Test (SAT): score of at least 500 in the reading section
- American College Test (ACT): score of at least 20 on the verbal section

Proof of English language competency can also be in the form of successful completion of a degree at an approved U.S. institution of higher education.

Applicants may apply for matriculation into any one of three semesters (fall, winter, or summer). The Committee on Admissions for NSU-KPCOM's Public Health Program will review all applications to this program and make recommendations to the program director and, subsequently, the dean of the college.

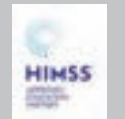

MASTER OF SCIENCE IN HEALTH INFORMATICS NONDEGREE-SEEKING STUDENTS

A nondegree-seeking student is one who wishes to take courses in NSU's Health Informatics program, but does not intend to pursue the master's degree or a graduate certificate at the time of application.

The nondegree-seeking student must provide the following admissions requirements in order to take classes in the program:

- a completed online application form
- a nonrefundable application fee of \$50
- official transcripts of all undergraduate, graduate, and professional education

Nondegree-seeking students are not guaranteed future acceptance into the Master of Science in Health Informatics Program or the Graduate Certificate in Health Informatics or Public Health Informatics programs.

DISASTER AND EMERGENCY MANAGEMENT PROGRAM

Did You Know?

According to scientists, natural disasters are predicted to increase not only in number, but in severity.

As society continues to expand, individuals are faced with new and unknown threats, and more people are living in areas prone to disaster (such as floodplains or along fault lines), putting more of the world's population at risk. This complexity, frequency, and severity of both man-made and natural disasters make the job of the emergency manager not only more difficult, but also more important.

The need for professionals who can manage these large and complex incidents has become more important than ever before. Companies and governments looking to mitigate and reduce the costs and damages to humanity, the environment, and property are actively seeking qualified individuals in this area.

MASTER OF SCIENCE IN DISASTER AND EMERGENCY MANAGEMENT EXIT OPPORTUNITIES

NSU's interprofessional M.S. program trains future leaders in the field of emergency management. It is designed to provide students with the theoretical knowledge and applied skills needed to work in this rapidly growing field.

Students will develop skills in

- leadership and management
- risk assessment
- continuity of operations
- disaster planning

This will enable them to build a core understanding of critical issues in the field, preparing them for both government and private sectors at the local and global levels.

The program content, offered in a synchronous online format, will enable working professionals to earn their degrees while continuing to work.

The program of study will include an online orientation at the beginning of the students' enrollment. An additional meeting will be coordinated near the program's conclusion to allow students to present their practicum project and have it evaluated.

The degree will allow students from a variety of disciplines to specialize in one of several concentrations, which is why a community research practicum at the local, state, federal, or international level will be a key component of the program.

The six degree concentrations offered are

- maritime safety and security
- public health
- cybersecurity
- fire administration
- criminal justice
- environmental hazards

Students can also choose not to specialize.

MASTER OF SCIENCE IN DISASTER AND EMERGENCY MANAGEMENT

COURSE OF STUDY

NSU's Master of Science in Disaster and Emergency Management (M.S. DEM) is a 36-credit-hour degree program delivered in a synchronous online format. The program consists of

- six core courses (18 credit hours)
 - one core course taken from a selection of courses related to leadership and management
 - one core course taken from a selection of courses related to threats and hazards
- six elective courses (the remaining 18 credit hours)

Students who choose to focus in one of the six concentration areas will take four of their electives (12 credit hours) from that area of concentration and their remaining electives (6 credit hours) from any of the remaining courses in the program.

Students who would prefer a more generalized curriculum may take courses from the general electives or any of the concentrations.

MASTER OF SCIENCE IN DISASTER AND EMERGENCY MANAGEMENT ADMISSIONS REQUIREMENTS

NSU's Master of Science in Disaster and Emergency Management Program evaluates the overall quality of its applicants, including academic achievement, life experience, recommendations, knowledge of the field of emergency management, and personal motivation.

The applicants must have

1. **a minimum of a bachelor's degree** from a regionally accredited college or university
2. **a cumulative, overall grade point average (GPA) of 3.0 or above on a 4.0 scale** from all institutions attended (**Applicants reviewed and accepted with below a cumulative 3.0 will be provisionally admitted and must earn a 3.0 or higher in the first 9 credit hours to continue in the program.**)
3. **the ability to express themselves in writing** through a written statement submitted with the application
4. **two letters of recommendation** from college or university instructors, employers, work colleagues, etc.
5. **demonstration of English proficiency** by any applicant whose native language is not English or who has graduated from a college or university where English is not the primary language, regardless of U.S. residency status (The standardized tests below currently satisfy NSU's and this program's English requirements for non-native English speakers.)
 - Test of English as a Foreign Language (TOEFL): score of 213 on the computer-based test or 79–80 on the Internet-based test
 - International English Language Testing System (IELTS): score of 6.0 on the test module
 - GMAT: score of 450
 - GRE: score of 1,000 (old format) or 306 (new format)
 - Scholastic Assessment Test (SAT): score of at least 500 in the reading section
 - American College Test (ACT): score of at least 20 on the verbal section

GRE, GMAT, or professional program entrance exam (e.g., MCAT or LSAT) scores are preferred from all applicants except

- those who currently have a terminal degree (e.g., Ph.D., D.M.D., D.V.M., J.D., or D.O.) or
- those who already hold a master's degree from a regionally accredited U.S. university or college

Applicants without terminal degrees or master's degrees who choose to apply, and are accepted, without taking a graduate or professional program entrance exam, will be required to attain a grade of B or higher in their first 9 credit hours to continue in the program.

MASTER OF SCIENCE IN DISASTER AND EMERGENCY MANAGEMENT NONDEGREE-SEEKING STUDENTS



A nondegree-seeking student is one who wishes to take courses in NSU's M.S. in Disaster and Emergency Management (DEM) program, but does not wish to pursue the master's degree at the time of application.

A limit of 15 credit hours will be allowed.

The nondegree-seeking student must provide the following admissions requirements in order to take courses in the program:

- a completed online application form
- a nonrefundable application fee of \$50
- official transcripts of all undergraduate, graduate, and professional education

If, after taking courses in NSU's M.S. in Disaster and Emergency Management program, a nondegree-seeking student chooses to pursue the degree, the student must submit a new and complete application to the program to become a degree-seeking student and must meet all requirements for admission into the degree program.

Previous coursework as a nondegree-seeking student does not guarantee acceptance into the degree program. If accepted into the program as a degree-seeking student, previous coursework may be eligible for transfer toward the degree.

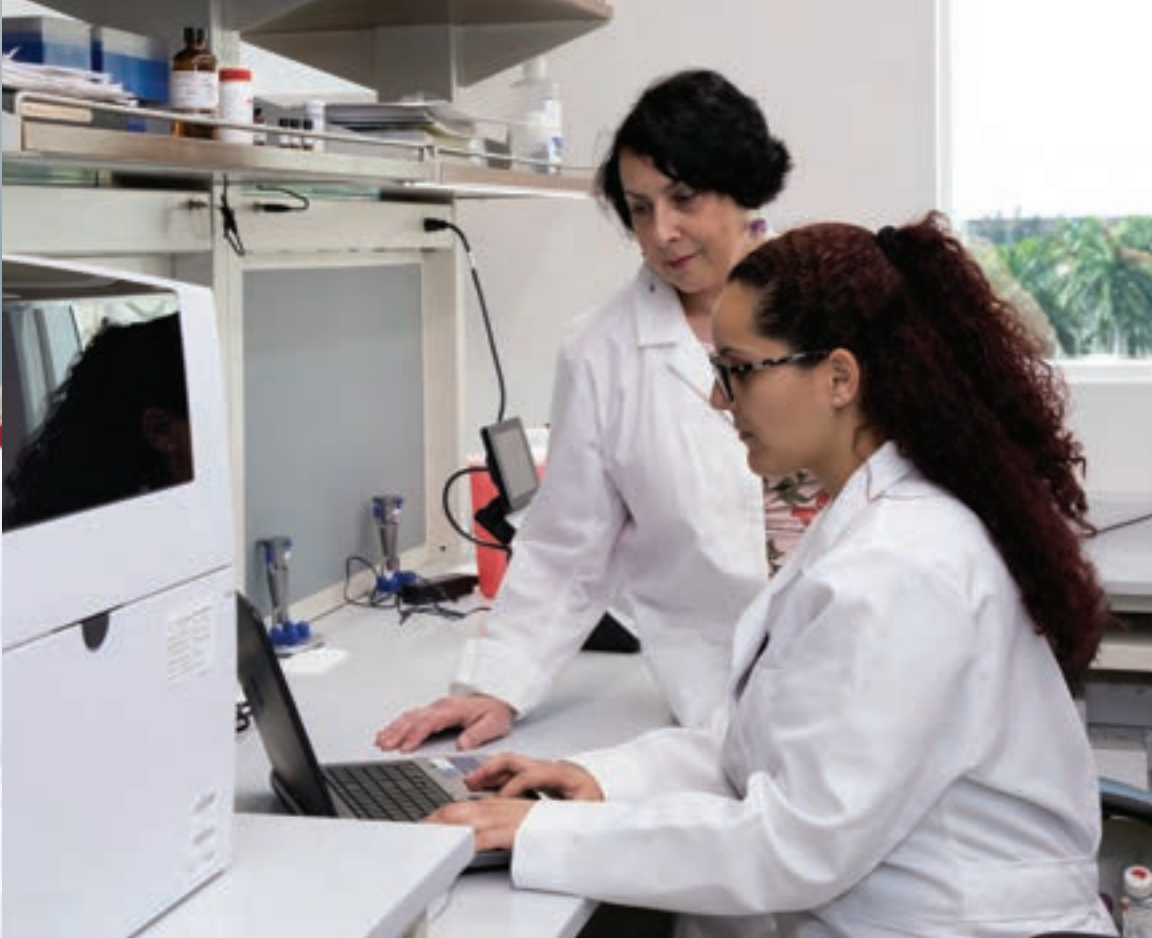

MEDICAL EDUCATION

MASTER OF SCIENCE IN MEDICAL EDUCATION PROGRAM INFORMATION

Education is at a crossroads. Physicians and other health professionals are sought after to serve as educators in their respective professions. While they have strong recognition as experts in their clinical discipline, they typically have little or no formal training in the educational process.

Today's students no longer merely watch, listen, and memorize information. Those medical professionals who choose to teach in the health professions must be guided by new innovations and contemporary technology in order to better understand how people learn.

It is important for educators in the health care professions to facilitate the learning process. Graduates of health programs should learn to connect and integrate multiple forms of reasoning (critical and creative thinking) and types of knowledge (formal and case-based) to provide the best patient care. Faculty members should be prepared to integrate formal knowledge and concepts fundamental to professional practice in a manner that is relevant to students and residents in a clinical context.

To this end, NSU's Dr. Kiran C. Patel College of Osteopathic Medicine (NSU-KPCOM) has developed a Master of Science in Medical Education program. This 30-credit-hour, online degree program is designed to help clinical faculty members and community preceptors enhance their professional education and teaching skills, as well as expand their ability to facilitate the learning process of students and residents in a variety of clinical teaching environments.

The rich, interprofessional platform of NSU-KPCOM and the Health Professions Division provides for an excellent environment for this degree program, as it parallels the interprofessional delivery model of patient-care settings. The program incorporates the most recent educational technologies into a robust, 10-course program delivered in 8-week terms.

The program is designed to be completed in as little as one year; however, students have a maximum of six years to complete it.

Faculty members for NSU's Master of Science in Medical Education Program are

- recognized scholars and educators from NSU and other major universities
- carefully selected on the basis of their subject expertise, teaching abilities, and professional involvement
- united in their desire to educate and to motivate students to use what they learn in the program to inspire others.

COURSE OF STUDY

The course of study for NSU's M.S. in Medical Education program was designed to develop professional educators with the knowledge and skills to lead in a dynamic and changing healthcare system.

The program includes completion of the 10 required courses identified in the curriculum. Students are expected to demonstrate the application of content knowledge to their specific profession and engage in robust dialogues with other health care professionals.

To be eligible for NSU's M.S. in Medical Education degree, students must satisfactorily complete the minimum 30 credit hours of coursework required, with a grade point average of 3.0 (B) or higher, within six years of matriculation.

MASTER OF SCIENCE IN MEDICAL EDUCATION ADMISSIONS REQUIREMENTS

NSU's M.S. in Medical Education program evaluates the overall quality of its applicants, including prior academic achievement, personal motivation, knowledge of health care, and profession-related experience.

Criteria for admission to NSU's M.S. in Medical Education program are

1. **a minimum of a bachelor's degree** from a regionally accredited college or university
2. **a cumulative, overall grade point average (GPA) of 3.0 or above on a 4.0 (or equivalent) scale** (preferred)

Applicants accepted with GPAs lower than the preferred may be required to interview. To be considered for acceptance, the applicant must participate in an interview if one is requested. An invitation to interview is not a guarantee of admission.

MASTER OF SCIENCE IN MEDICAL EDUCATION APPLICATION PROCEDURES

The Office of Admissions processes applications on a year-round basis. Students are admitted to begin studies during the fall, winter, or summer semesters.

It is the applicant's responsibility to have this coursework evaluated. An official course-by-course evaluation with a cumulative grade point average must be sent directly from the evaluation service to NSU's Enrollment Processing Services.

Upon receipt of the completed application and required material, the Committee on Admissions will review the applicant's file and make recommendations to the program director. The director submits recommendations for admission to the dean. The final decision on admission is made by the dean.

MASTER OF SCIENCE IN MEDICAL EDUCATION NONDEGREE-SEEKING STUDENTS

A nondegree-seeking student is one who wishes to take courses in NSU's Master of Science in Medical Education Program, but does not intend to pursue the master's degree.

The nondegree-seeking student must provide the following admissions requirements in order to take classes in the degree program:

- **a completed online application** with a nonrefundable application fee of \$50
- **official transcripts** of all coursework attempted by the applicant from all colleges and universities, including undergraduate, graduate, and professional education

Nondegree-seeking students are not guaranteed future acceptance into NSU's Master of Science in Medical Education Program.

If, after taking classes in the program as a nondegree-seeking student, the student wishes to become degree seeking, the student must submit a new and complete application to the program to become a degree-seeking student and must meet all the requirements for admission to NSU's Master of Science in Medical Education Program.

Nondegree-seeking students can enroll in a maximum of five courses or 15 credit hours.

Did You Know?

If accepted into NSU's Master of Science in Medical Education Program, courses/credits that were taken as a nondegree-seeking student will be automatically applied toward the degree.

MASTER OF SCIENCE IN MEDICAL EDUCATION TRANSFER OF CREDITS

Applicants or enrollees of NSU-KPCOM's Master of Science in Medical Education Program may petition for a transfer of a maximum of 6 credit hours from a regionally accredited institution toward their degree for degree-seeking students. Any exceptions require the written approval of the program director.

To be considered for transfer of credit, courses must have been

- completed less than three years prior to the beginning of the student's first semester in the program
- substantially equivalent to courses offered in the program, as determined by the program director and appropriate faculty members
- successfully completed with a grade of B (80 percent) or better

An accepted applicant to the program who wishes to receive transfer credit must submit a written request and the appropriate verification documents (e.g., official transcripts, syllabi, and catalogs) to the program director.

NSU's Dr. Kiran C. Patel College of Osteopathic Medicine offers an innovative Master of Science (M.S.) in Nutrition degree in response to the growing demand throughout the United States for qualified nutrition experts who are prepared at a mastery level.

Did You Know?

Ongoing changes in the American healthcare system have increased demand for wellness and preventive services, which include nutrition, in almost all areas of practice. Nutrition assessment and nutrition intervention for chronic diseases are important components of the new health care reform mandates.

The program is designed to further the education of those who want to integrate nutrition into other health professions and complement the academic preparation for those who wish to enter the field of nutrition and dietetics.

This 30-credit-hour, online program incorporates the latest technology and tools in distance learning through live meetings that provide opportunities for students to collaborate and interact with faculty members and fellow students.

The curriculum offers opportunity to students to customize their program of study with selected concentrations or take a variety of electives.

The rich, interprofessional platform of NSU's Dr. Kiran C. Patel College of Osteopathic Medicine and the Health Professions Division provides an excellent environment for this program.

Did You Know?

The job outlook for appropriately trained nutrition professionals is better than the average for other health-related disciplines. With the aging of America and the growth worldwide of people over age 65, nutritionists also play a key role in senior health, positive aging, preventative care, and managing chronic disease.

NSU's M.S. in Nutrition program provides students with

- principle concepts in human nutrition
- analysis of scientific evidence
- strategies for health care practitioners
- mastery-level skills for advanced practice
- interprofessional collaboration

It is also an excellent interprofessional, graduate degree for students in other health professions, such as medicine, dentistry, optometry, nursing, or pharmacy. Some settings where graduates find jobs include hospitals, long-term care facilities, physician offices/private clinics, outpatient care centers, schools and universities, home health companies, corporations, athletic training centers or gyms, health departments, food production centers and plants, health care insurance companies, and private consulting businesses.

Did You Know?

According to the U.S. Bureau of Labor Statistics (2021), employment in the nutrition field is expected to increase 7 percent during the next seven years. Job growth is primarily expected in the areas of wellness, prevention of disease with diet and foods, and greater integration of nutrition practice into primary care. Career outlooks incorporate a variety of specialties and settings.

NSU's M.S. in Nutrition degree will meet the future standards of practice for registered dietitian nutritionists, which take effect in 2024 and require a minimum level of preparation with a master's degree in nutrition or similar field for those who have already achieved that professional credential.

✓ TIP

Those applicants seeking eligibility for entry-level practice should consider the Professional Practice Concentration (74 credit hours). This is a coordinated graduate degree program providing about 1,000 hours in supervised experiential learning. It is approved by the Accreditation Council for Education in Nutrition and Dietetics (ACEND) to prepare registered dietitian nutritionists.

Please consult local licensing and scope of practice laws to determine what training and credentials are required in the intended state of practice.

NSU's M.S. in Nutrition program is approved to meet the academic requirements for the Certified Nutrition Specialist (CNS) credential. Earn the protected title of CNS to set yourself apart in a variety of services, including education, food science, wellness, sports and fitness, and integrative health practice. Candidates may be able to receive up to 300 hours of supervised training in this program. The Board of Certified Nutrition Specialists reviews each candidate individually, including transcripts and 1,000 hours of required practical experience, to determine eligibility. The program may also be a source of continuing graduate education for students from athletic training, nutrition practice, exercise science, and health and physical education programs.

NSU's Master of Science in Nutrition provides an excellent interprofessional graduate degree for students in other health professions, such as medicine, dentistry, optometry, nursing, or pharmacy.

MASTER OF SCIENCE IN NUTRITION

COURSE OF STUDY

NSU's Master of Science in Nutrition course of study is designed so that all students take a 21-credit-hour core in the fundamentals of nutrition. All students also complete a culminating capstone project focused on an original individual research topic or community-based impact idea for implementation.

Students select electives to complete a generalist program of study or declare concentrations in sports nutrition, community nutrition, functional nutrition and herbal therapy, nutrition research, or professional practice. Students may take up to six years to complete the general degree program in a flexible, self-paced option, or can complete the degree in about two years. A full-time course of study is considered 6 credit hours. Academic advising can help create a plan tailored for each student.

✓ TIP

As the requirements for the professional practice concentration are highly prescribed, students should check the dedicated section for this option for full details.

NSU's M.S. in Nutrition program offers students from varied undergraduate disciplines, or from other graduate areas of study, the knowledge and practical skills to apply theory and innovative concepts within their own area of influence.

Students explore various components including

- contemporary research
- evidence-based practice
- therapeutic concepts with diet
- nutrition's relationship to health and disease
- programmatic approaches in populations
- emerging topics, such as genetic applications and plant-based eating patterns

Did You Know?

The Dietary Guidelines for Americans emphasize the relationship between food choices, disease management, and prevention. Successful education of the public and interprofessional health practitioners will require nutrition professionals with advanced training in nutrition as it relates to health promotion and disease prevention.

PROFESSIONAL PRACTICE CONCENTRATION

This highly prescribed, 74-credit-hour concentration prepares prospective students for entry-level practice as registered dietitian nutritionists and is approved by the Accreditation Council for Education in Nutrition and Dietetics (ACEND).

In addition to the core courses, special project, and other program requirements noted above, students are required to attend a hybrid curriculum with both online and on-site classes to gain the full professional competencies required by ACEND. Students receive approximately 1,000 hours in supervised, experiential learning to meet eligibility requirements.

This concentration admits students once a year, during the summer term, and requires additional admissions requirements above those stated for the M.S. in Nutrition program.

MASTER OF SCIENCE IN NUTRITION ADMISSIONS REQUIREMENTS

NSU's M.S. in Nutrition program evaluates the overall quality of its applicants, including academic achievement, personal motivation, knowledge of health care, profession-related experience, and letters of recommendation.

Criteria for admission to NSU's M.S. in Nutrition program are

1. **a minimum of a bachelor's degree** from a regionally accredited college or university
2. **successful completion of at least one semester of the following courses with a grade of 2.0 or higher:**
 - anatomy and physiology (or equivalent course approved by program director)
 - biology
 - organic chemistry

Completion of one semester course of biochemistry is preferred, but not required. All prospective applicants are invited to contact the program office to develop a plan for entry into the program.

3. **a cumulative, overall grade point average (GPA) of 3.0 or above on a 4.0 (or equivalent) scale (preferred)**
4. **the ability to clearly express one's self in writing**, as demonstrated by a written statement submitted in the application to the program

Did You Know?

In addition to the courses above, candidates for the professional practice concentration must have successfully completed at least one course in human nutrition, biochemistry, statistics, general chemistry with lab, and microbiology with a grade of 2.0 or higher, and have a successful interview.

It is the applicant's responsibility to have this coursework evaluated. An official course-by-course evaluation with a cumulative grade point average must be sent directly from the evaluation service to NSU's Enrollment Processing Services.

4. **demonstration of English proficiency** by any applicant whose native language is not English or who has graduated from a college or university where English is not the primary language, regardless of U.S. residency status (The standardized tests below currently satisfy NSU's and this program's English requirements for non-native English speakers.)

- Test of English as a Foreign Language (TOEFL): score of 213 on the computer-based test or 79–80 on the Internet-based test
- International English Language Testing System (IELTS): score of 6.0 on the test module
- Pearson Test of English—Academic: score of 54
- American College Test (ACT): score of at least 20 on the verbal section
- Duolingo English Test: score of 100 or higher

Test results must be sent directly from the testing agency to the center you applied to. Proof of English language competency can also be in the form of successful completion of a degree at a regionally accredited U.S. college or university.

Upon receipt of the completed application and required material, the Committee on Admissions will review the application and the applicant's file and make recommendations to the program director. The director submits a recommendation on admission to the dean. The final decision on admission is made by the dean.



MASTER OF SCIENCE IN NUTRITION TRANSFER OF CREDITS

Applicants or enrollees of NSU-KPCOM's Master of Science in Nutrition Program may petition for a maximum transfer of 6 credit hours toward their degree from a regionally accredited institution for degree-seeking students. Any exceptions require the written approval of the program director.

To be considered for transfer of credit, courses must have been

- completed less than three years prior to the beginning of the student's first semester in the program
- substantially equivalent to courses offered in the program, as determined by the program director and appropriate faculty members
- successfully completed with a grade of B (80 percent) or better

Transfer course grades are not calculated toward the student's grade point average.

An accepted applicant to the program who wishes to receive transfer credit must submit a written request and the appropriate verification documents (e.g., official transcripts, syllabi, and catalogs) to the program director.

Applicants may receive up to 6 credit hours for certain professional qualifications and work experience. The program follows the university's policy from the Office of Transfer Evaluation Services (TES) regarding assessment of prior learning outside of the program. The guidelines can be found at nova.edu/tes/graduate/index.html.

MASTER OF SCIENCE IN NUTRITION NONDEGREE-SEEKING STUDENTS

A nondegree-seeking student is one who wishes to take courses in NSU's Master of Science in Nutrition Program, but does not intend to pursue the master's degree.

The nondegree-seeking student must provide the following admissions requirements in order to take classes in NSU's Master of Science in Nutrition Program:

- a completed online application
- official transcripts of all undergraduate, graduate, and professional education
- a nonrefundable application fee of \$50

Nondegree-seeking students are not guaranteed future acceptance into NSU's M.S. in Nutrition program. If, after taking classes in the program as nondegree-seeking, students wish to become degree-seeking, they must apply to the master's degree program as new students and meet all the requirements for admission.

If accepted into the degree program, credits with the prefix NUT that were taken as a nondegree-seeking student will be automatically applied toward the degree.

Nondegree-seeking students can enroll in a maximum of four courses, or 12 credits, and are not eligible for financial aid.

PROGRAM INFORMATION

NSU's Graduate Certificate in Functional Nutrition and Herbal Therapy is designed for practicing health professionals to understand the tenets of herbal and functional nutrition in a systems-based approach.

The program's innovative courses will highlight

- functionality of body systems
- etiology of diseases
- toxic reactions of herbs
- interactions with medications
- herbal therapy for special populations
- dietary approaches to imbalances in the body
- roles of health care professionals in educating patients on using herbal supplements safely

Graduates will gain additional practice competencies and skills to integrate valuable information into the care of patients.

This certificate program option consists of 15 credit hours of graduate-level courses and is eligible for financial aid. Once the certificate program is completed and awarded, these courses can no longer be applied toward the degree program.

ADMISSIONS REQUIREMENTS

Working from an interprofessional perspective within NSU's Dr. Kiran C. Patel College of Osteopathic Medicine, eligible individuals may include audiologists, dentists, physicians, physician assistants, physical therapists, pharmacists, registered dietitians, psychologists, or optometrists.

Other health-related professionals with certifying credentials and graduate education may apply and will be reviewed by the admissions committee of NSU's M.S. in Nutrition degree program.

All applicants must submit

- proof of a bachelor's degree or higher from a regionally accredited college or university
- official transcripts
- a completed application form
- a nonrefundable application fee of \$50
- an undergraduate GPA of 3.0 or above on a 4.0 scale (preferred)
- evidence of current health professional license or other certifying credentials

APPLICATION PROCEDURES

Applicants may apply for matriculation into any one of three semesters (fall, winter, or summer).

Upon receipt of the completed application and required materials, the Committee on Admissions will review the applicant's file and make recommendations to the program director.

All final decisions on admission are made by the dean of the college.

Residents will obtain additional information from this graduate-level program, which helps to achieve competency in several elements. - a bachelor's, master's, or doctoral degree from a regionally accredited college or university
- a cumulative grade point average (GPA) of 3.0 or above on a 4.0 scale (preferred)
- good academic standing, and a letter of recommendation from the dean or program director of the other college or program, if applicant is enrolled in another area of study within Nova Southeastern University
- timely submission of application materials to enable the Office of Admissions and the admissions committee to process the application promptly

Health care-related experience is desirable, but not required.

GRADUATE CERTIFICATE IN HEALTH PROFESSIONS PREPARATION PROGRAM INFORMATION

NSU's Dr. Kiran C. Patel College of Osteopathic Medicine offers an innovative program in Health Professions Preparation for students who are interested in pursuing a career in osteopathic medicine but need more academic preparation prior to enrollment.

Designed by faculty members in the college, NSU's Graduate Certificate in Health Professions Preparation (CHPP) is unique. It offers direct entry into NSU's D.O. program upon completion of the two-semester certificate program with a 3.6 GPA. Students who graduate with a GPA between 3.4 and 3.59 are guaranteed an interview for the following fall's D.O. class. The college does not guarantee interviews or admissions for graduates from any other program, so this is an exclusive opportunity to develop the skills necessary to become a competent and compassionate future Shark physician.

Did You Know?

It is extremely common for students to enter some type of postbaccalaureate program prior to matriculating into medical school to gain a stronger academic or clinical background. Many students previously enrolled in our program have entered medical school and are now ranked at the top of their class!

GRADUATE CERTIFICATE IN HEALTH PROFESSIONS PREPARATION ADMISSIONS REQUIREMENTS

The Graduate Certificate in Health Professions Preparation (CHPP) Program evaluates the overall quality of its applicants, looking at academic achievement, personal motivation, knowledge of health care, osteopathic medicine profession-related experiences, and recommendations. All applicants to the program must have

1. **an NSU CHPP (postbaccalaureate) application**, along with a \$50, nonrefundable application fee

- an American Association of Colleges of Osteopathic Medicine Application Service (AACOMAS) application on file from the current D.O. cycle

OR

- a completed PostBacCAS application

2. **official transcripts** of all coursework, even if currently in progress (even if applicant has previously submitted a service application)

3. **official Medical College Admissions Test (MCAT) scores** of 497 or higher (cannot be older than three years at the time of matriculation into the CHPP program)

- A repeat of this test will not be necessary for entrance into NSU's D.O. program unless the MCAT score is below 500.
- An official MCAT score is acceptable if part of the service application or AACOMAS.
- MCAT scores sent by the applicant can be validated with a verification code.

4. **letters of recommendation** submitted according to AACOMAS procedures

- one from a physician (D.O. or M.D.)

AND either

- one letter from the preprofessional committee

If applicant has been out of school for at least two years, please contact an admissions counselor.

The applicant's first step in the application process is to initiate an application to the CHPP program by first applying to NSU through either the AACOMAS or the PostBacCAS application services.

Step 1: AACOMAS Path

The college participates in the American Association of Colleges of Osteopathic Medicine Application Service (AACOMAS) for the receipt and processing of applications. All students who are currently applying to NSU's D.O. program must complete an AACOMAS application and, thus, have already started the application process for the CHPP program. Students who submit through PostBacCAS will need to fill out an AACOMAS application to matriculate into the D.O. program at a later date. AACOMAS takes no part in the selection of students.

The applicant must submit the following materials to AACOMAS by January 15 to complete the primary application process:

 - one from a physician (D.O. or M.D.)

Step 2

A personal interview is a part of the admissions process; however, being interviewed is not a guarantee of admission. Not all applicants will be granted an interview. Those selected for an interview will be notified of the date and time of such interview by the Office of Admissions.

Notice of acceptance will be on a rolling or periodic schedule; therefore, because of the limited number of spaces available in each class, early completion of the application is in the best interest of the applicant

After acceptance, final and official documents and requirements must be received by the Office of Admissions within 90 days following the start of the first term. If these final and official documents are not received, or other requirements are not met by that time, the applicant will not be able to continue enrollment.

COUPLE AND FAMILY THERAPY

Graduate students in the Department of Couple and Family Therapy receive clinical training at NSU's Brief Therapy Institute (BTI). The BTI is a state-of-the-art training facility where highly motivated graduate students pursuing degrees in the field of couple/marriage and family therapy are supervised by highly qualified, licensed, and AAMFT-approved faculty supervisors. Students also have training opportunities in the Medical Family Therapy Clinic at the university's Sanford L. Ziff Health Care Center (also located on NSU's Fort Lauderdale/Davie Campus). NSU students are trained to work with families and individuals of diverse ethnic and cultural backgrounds, religious affiliations, and sexual orientations.

DOCTOR OF PHILOSOPHY (PH.D.) IN COUPLE AND FAMILY THERAPY PROGRAM INFORMATION

NSU's residential Ph.D. in Couple and Family Therapy is a variable-credit program (81-114 credit hours) designed for individuals holding master's degrees who wish to fully grasp both the historical aspects and the cutting-edge theory informing the current practice of family therapy, while demonstrating the place of qualitative and quantitative research. It enhances students' clinical skills, allowing them to become top-level practitioners.

The program is dedicated to understanding the relationship between theoretical ideas and the variety of established and emerging schools of family therapy. NSU's residentially offered Ph.D. in Couple and Family Therapy program can be completed in a maximum of eight years.

PH.D. IN COUPLE AND FAMILY THERAPY EXIT OPPORTUNITIES

NSU's Ph.D. in Couple and Family Therapy program prepares graduates for careers as professors, researchers, supervisors, and senior clinicians. Graduates can look forward to productive careers in employment settings that are

- academic
- supervisory
- clinical
- community-based

During the Ph.D. program, students may also fulfill the academic requirements for becoming a clinical member and/or approved supervisor in the American Association for Marriage and Family Therapy (AAMFT). MASTER OF SCIENCE (M.S.) IN COUPLE AND FAMILY THERAPY PROGRAM INFORMATION

NSU's M.S. in Couple and Family Therapy program is designed to help students develop clinical excellence and prepare for careers as marriage and family therapists. The program consists of 60 credit hours of coursework and clinical practice. Training is concentrated on brief, interactional models of family therapy, preparing graduates to practice in a time-sensitive, cost-effective manner.

Students may enter NSU's M.S. in Couple and Family Therapy program, which is offered on the university's Fort Lauderdale/Davie Campus, in the fall or summer semester. Students may enroll full or part time, taking 6 to 12 credit hours per semester. Students who begin in the summer semester may be part time for that semester. Classes typically meet 3:00–6:00 p.m. OR 6:00–9:00 p.m., with the exception of the practicum.

Did You Know?

Students who attend full time can expect to complete the program in approximately two years. Part-time students will complete the program in three years or less, depending on the pace of study. Summer attendance is required.

✓ TIP

The program fulfills the academic requirements for state licensure in Florida and for clinical membership in the American Association for Marriage and Family Therapy, but additional post-master's degree clinical experience is required for both credentials.

COUPLE AND FAMILY THERAPY ADMISSIONS REQUIREMENTS

NSU's Department of Couple and Family Therapy faculty members carefully consider a number of factors when choosing applicants for the Ph.D. in Couple and Family Therapy and D.M.F.T. programs. These include knowledge of systemic theory as it relates to various approaches of family therapy, level of prior clinical experience, evidence of commitment to advanced graduate training in the social sciences, interpersonal style, prior graduate GPA, and professional English writing skills.

Criteria for admission to NSU's Ph.D. in Couple and Family Therapy and Doctor of Marriage and Family Therapy programs are as follows:

- a master's degree from a regionally accredited institution
- a minimum cumulative GPA of 3.5 or higher
OR a total score of 300 or higher on the combined verbal and quantitative sections of the Graduate Record Exam (GRE), taken within the past five years

Qualities considered when evaluating applicants for admission into the M.S. in Couple and Family Therapy program include a major emphasis on applicants who are familiar with, and interested in, learning systemic theories and therapies. Applicants should also demonstrate comfort with cultural and sexual diversity and an ability to connect to people in crisis.

Criteria for admission to NSU's M.S. in Couple and Family Therapy are as follows:

- a completed bachelor's degree from a regionally accredited college or university
- a minimum cumulative grade point average (GPA) of 3.0 or higher on a 4.0 scale in the last 60 semester hours of undergraduate coursework
OR a master's degree with an overall cumulative GPA of 3.0 or better
OR a total score of 300 or higher on the combined verbal and quantitative sections of the Graduate Record Exam (GRE), taken within the past five years

Human relations professionals, health professionals, business managers, or supervisors, among many others, would also benefit from the application of systemic family principles to their efforts.

This certificate takes advantage of NSU's unique access to a multidisciplinary faculty, incorporating coursework in family systems healthcare, systems and communication theories, and human development across the life span. The multidisciplinary approach prepares NSU students to apply knowledge about family systems directly to their work environment and demands.

Students may enroll full or part time, taking 3 to 9 credit hours per term. Students can expect to complete the graduate certificate program in 10–15 months, depending on the pace of study. Summer attendance is required.

FAMILY STUDIES CURRICULUM

The Graduate Certificate in Family Studies is a 24-credit-hour program (eight courses). The curriculum includes coursework on systemic thinking in family studies, topics in grief and loss, human development, infant mental health, and diversity and psychosocial issues.

ADMISSIONS REQUIREMENTS

Applicants must have

1. a bachelor's degree from a regionally accredited institution
2. a minimum cumulative grade point average (GPA) of 3.0 in last 60 semester hours of undergraduate coursework or a master's degree with an overall cumulative GPA of 3.0 or better



APPLICATION PROCEDURES

The programs admit applicants three times a year, in fall, winter, and summer.

All applicants must complete and submit the following:

1. **a complete online application form**, along with a \$50 U.S., nonrefundable application fee (online applications available at *apply.nova.edu*)
2. **official transcripts** of all coursework attempted by the applicant from all colleges and universities attended and/or agency evaluation of any foreign degrees

It is the responsibility of the applicant to ensure that arrangements are made for all transcripts to be sent. A final transcript of all the applicant's work up to the time of matriculation must be forwarded to the Office of Admissions prior to matriculation.

Coursework taken at foreign institutions must be evaluated for U.S. institution equivalence by an approved National Association of Credential Evaluation Services (NACES) organization, such as one of the services listed below.

It is the applicant's responsibility to have this coursework evaluated. An official course-by-course evaluation with a cumulative grade point average must be sent directly from the evaluation service to NSU's Enrollment Processing Services.

6. **proof of English proficiency** by any applicant whose native language is not English or who has graduated from a college or university where English is not the primary language, regardless of U.S. residency status (The standardized tests below currently satisfy NSU's and this program's English requirements for non-native English speakers.)

a. Test of English as a Foreign Language (TOEFL): minimum score of 213 on the computerized or 79–80 on the Internet-based test

b. International English Language Testing System (IELTS): minimum score of 6.0 on the test module

Test results must be sent directly from the testing agency to the center where you applied. Proof of English language competency can also be in the form of successful completion of a degree at a regionally accredited U.S. college or university.

Upon receipt of the completed application and required materials, a faculty committee will review the application. Based on the merit of the submitted documents, the committee may invite a select group of applicants for an interview. Once a decision has been made, notification is sent via email to the address on file.

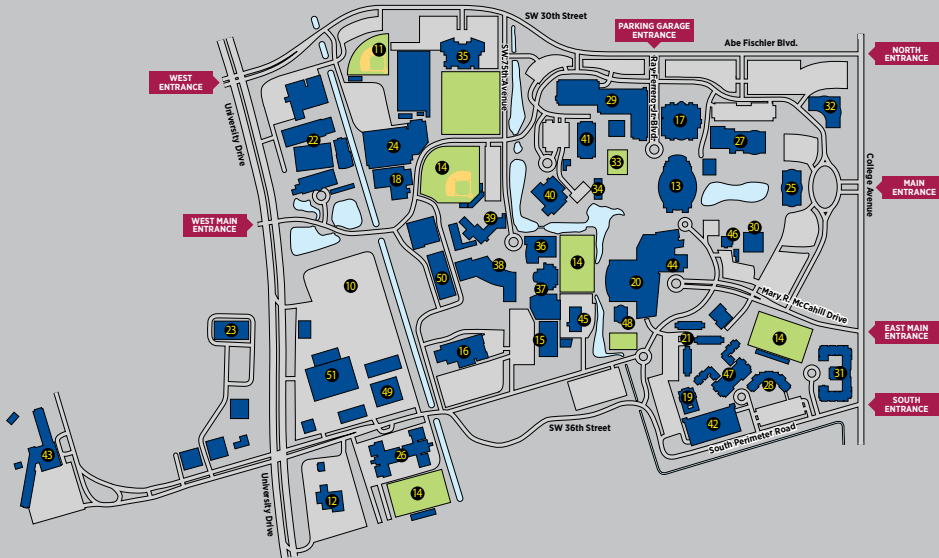

PROVISIONAL ACCEPTANCE

Students are provisionally admitted to a degree-seeking program based on a review of unofficial transcripts or other specific program admission requirements. However, this admission includes a condition that final and official transcripts, documents, and requirements must be received within 90 calendar days from matriculation. If these final and official transcripts, documents, and/or requirements are not received by that time, the student will not be allowed to continue class attendance. Financial aid will not be disbursed to a provisional/ conditional student until he or she has been fully admitted as a regular student (all admissions requirements have been approved by the college/program admissions office). Students who have an unpaid balance 30 days from the start of the term will be assessed a \$100 late fee.
