### Doctoral Student is Awarded STUEY's Highest Honor

Graduate School of Humanities and Social Sciences (SHSS) doctoral student in Conflict Analysis and Resolution (DCAR), Joshia Osamba, took home a Student Life Achievement Award (STUEY) for Nova Southeastern University Student of the Year at the 2003 Student Life Achievement Awards on April 15, 2003.

Osamba received the prestigious STUEY for his engagement in University life, which has contributed to the overall quality of the SHSS and NSU community.

The NSU STUEY's is the vision of the Dean of Student Affairs, Dr. Brad Williams. Williams set out to create a celebration to recognize those who further a sense of campus community. Osamba competed against 13 other hopefuls for the STUEY's highest award.

While at SHSS, he has published three articles in well-known peer-reviewed academic journals and has two forthcoming articles.

Osamba is the first international student representative to the SHSS Student Association, and he is currently the first president of the SHSS International Student Club. Osamba also participates in all activities of the Nova International Student Association

### SHSS Receives Generous SUPERB Grant

Project SUPERB (Students United with Parents & Educators to Reduce Bullying) is the philanthropic vision of Jeremy Ring and his wife Sharon. The Rings came to the School of Humanities and Social Sciences with a dream that they could put their money where their passions were; they were very interested in launching a project that addressed the devastation and pervasiveness of childhood bullying. They were interested in SHSS because they had heard of the "systemic approach" that was employed by the faculty and students here, and they were curious to find out more about how this might be applied to school



bullying. After a series of discussions with a group of faculty and administration representatives, the Rings agreed that they would commit themselves to funding a \$100,000 gift to the school, earmarked for the development of a pilot project to be launched within the Broward County School system.

Their generous gift has been used to fund two doctoral level Research Assistantships that have allowed Jewell Bexley (DFT) and Hansa Dineth

With other DCAR students and faculty, Osamba is involved in the Theories Working Group, a collaborative research and writing project. A skilled researcher and writer, Osamba has been a valued graduate assistant during the current academic year.

"Joshia is a skillful practitioner. He especially values DCAR's

practical component, and has been engaged in practice in the local community," said DCAR professor, Jessica Senehi.

While at NSU, Osamba has organized three workshops for the "Fathers Count" program of the Urban League of Florida, conducted more than twenty seminars for the Salvation Army Transition Department, Fort Lauderdale, and facilitated a community discussion addressing ethnic conflicts in South Florida.

"Joshia has especially enjoyed the teaching practicum for which he and other DCAR

students are assisting Dr. Judith McKay, in teaching a course on "Dispute Resolution" for undergraduates students at the Farquhar College of Arts and Sciences," said Senehi.

Osamba is committed to his education and the field of conflict resolution. His long-term goal is to be a university professor in Kenya and serve others as a practitioner of conflict resolution and peace building at the community and international levels.

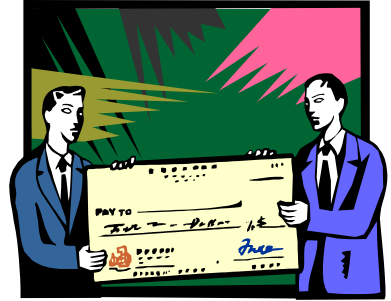

The department's new Doctor of Marriage and Family Therapy degree program (DMFT) is off to a very successful first year. This new program enrolled a total of 10 new students in the academic year 2002-2003. The DMFT degree program is only the second one of its kind in the country, and it is designed for mid-career working adult students who want to specialize in clinical applications of marriage and family therapy practice. Students are drawn to the DMFT program as an alternative to the traditional Ph.D. degree in two ways. First, the DMFT curriculum emphasizes additional clinical training and second, instead of completing a dissertation, DMFT students are required to complete an Applied Clinical Project or ACP. The ACP is designed to showcase the students' applied clinical research in a format that helps them make their mark in a competitive clinical marketplace.

### The Graduate School of Humanities and Social Sciences (SHSS) is celebrating 15 Years of Excellence.

SHSS has grown not only in enrollment but also in the number of programs offered over the past 15 years. SHSS offers doctoral, master's, graduate certificate, and graduate minor programs in conflict analysis and resolution, family therapy, peace studies, college student personnel administration, health care conflict resolution, family systems healthcare, and family studies. SHSS also offers joint graduate degree programs the Criminal Justice Institute and the Shepard Broad Law Center. Most of the graduate programs are offered in both on-campus and online formats.

What makes SHSS unique is that its programs are multidisciplinary learning processes that provide hands-on experience. Family therapy students learn to cultivate their skills at the school's Brief Therapy Institute, a clinical site that provides therapeutic assistance to couples and families. The Department of Conflict Analysis and Resolution provides practical experience in mediation and other professional skills application through its Community Resolution Services, which provides direct services and trainings through community organizations and agencies.
